The driver of Unit 2 confirmed that he had to come to a stop quickly because traffic was congested and backing up quickly. 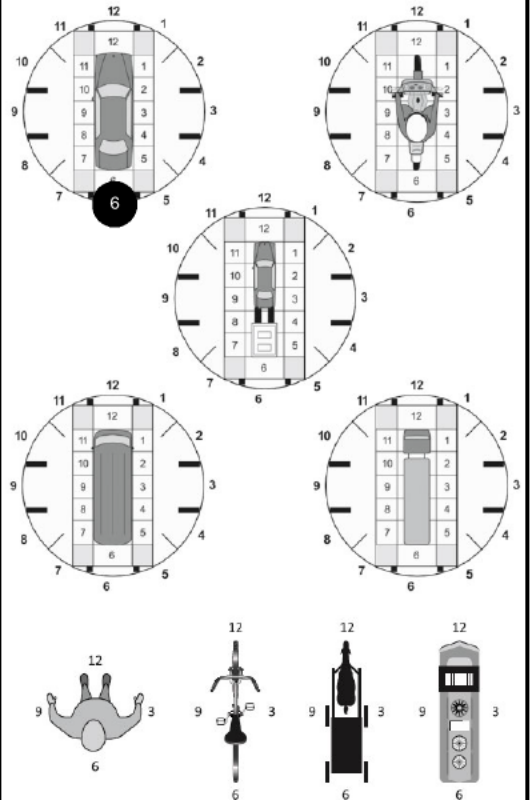
